

# Code of Conduct

## 1. Code of Conduct

1.1 This Code of Conduct ('Code') relates to Sektor Group Ltd, Sektor Pty Ltd, Sektor Ltd, Sektor Distributors Sdn., Bhd., and Sektor (Thailand) Co., Ltd, (together 'Sektor') and, where relevant, operates in conjunction with other policies relating to minimum standards of behaviour and conduct, the Contract of Employment or Contract for Services.

## 2. Commencement of the Code

2.1 This Code replaces all other codes of conduct of Sektor, if any (whether written or not).

## 3. Scope

3.1 The Code applies to all employees, agents and contractors (including temporary contractors) of Sektor, collectively referred to as 'workplace participants'.

3.2 The Code does not form part of any employee's contract of employment. Nor does it form part of any other workplace participant's contract for services.

## 4. Purpose

4.1 Sektor recognises the importance of a work environment which actively promotes best practice. The purpose of this Code is to describe the standards of behaviour and conduct expected from workplace participants in their dealings with customers, suppliers, clients, co-workers, management and the general public.

4.2 Sektor expects all workplace participants to observe the standards set out in this Code. Compliance with this Code is expected and non-compliance may result in disciplinary action up to and including the termination of employment or contract for services.

## 5. The Code Requirements

5.1 All workplace participants are expected to observe the highest standards of ethics, integrity and behaviour during the course of their employment or engagement with Sektor. This Code provides an overview of Sektor's fundamental business values. It is by no means exhaustive, but summarises some of Sektor's most important policies, which are based on standards that underlie business ethics, professional integrity and standards that apply to all workplace participants.

5.2 As representatives of Sektor, all workplace participants are expected to conduct themselves in a professional and courteous manner and observe the following standards of behaviour both inside and outside the workplace. Sektor has a legitimate interest in the private activities of workplace participants where such activities may bring disrepute upon Sektor in its relationships with customers, clients, suppliers, and the general public at large and may possibly call the workplace participant's fitness for continued employment or to provide services, into question. Where the workplace participant can be perceived as representing Sektor, they must;

- a) comply with all laws, policies, procedures, rules, regulations and contracts;
- b) comply with all lawful and reasonable directions from Sektor;
- c) be honest and fair in dealings with customers, clients, suppliers, co-workers, management and the general public;
- d) display the appropriate image of professionalism at the workplace. This may include wearing required safety equipment, and ensure their appearance is neat and tidy;

- e) treat customers, clients, suppliers, co-workers, company management and the general public in a non-discriminatory manner with proper regard for their rights and dignity. In this regard, discrimination, victimisation or harassment based on a person's race, colour, religion, national origin, age, sex, sexual orientation, marital status, family responsibilities, pregnancy or potential pregnancy, union membership or non-membership, mental or physical disability, or any other classification protected by law, will not be tolerated;
- f) promptly report any violations of law, ethical principles, policies and this Code to senior management;
- g) maintain punctuality. If a workplace participant is late or cannot report for work, they are to telephone and let the Manager know as soon as possible;
- h) not use work time for private gain. If a workplace participant is required to leave the work premises for personal reasons they should advise their Manager well in advance;
- i) maintain and develop the knowledge and skills necessary to carry out duties and responsibilities;
- j) observe health and safety policies and obligations, and co-operate with all procedures and initiatives taken by Sektor in the interests of work health and safety;
- k) be truthful in all dealings with persons encountered at the workplace. Workplace participants must not make false or misleading declarations during the performance of their duties or when providing services on behalf of Sektor. A declaration can be considered to be misleading if information is omitted or presented in a manner that enables a misleading view of the situation to be formed. This includes failure to comply with reporting requirements and falsifying records and other documents;
- l) refrain from any form of conduct which may cause any reasonable person unwarranted offence or embarrassment or give rise to the reasonable suspicion or appearance of improper conduct or biased performance;
- m) not act for an improper or ulterior purpose to the detriment (whether perceived or actual) of Sektor;
- n) not abuse the advantages of their position for private purposes, or solicit or accept any gift or benefit in connection with their employment or engagement which might compromise, or be seen to compromise their integrity or Sektor's reputation;
- o) respect Sektor's ownership of all of its property including but not limited to funds, equipment, supplies, books, records and confidential information (however described);
- p) maintain during their employment or engagement with Sektor and after the termination of employment or engagement, the confidentiality of any confidential information, records or other materials acquired during the employment or engagement with Sektor;
- q) not accept any employment with another organisation that is a supplier or competitor of Sektor, or any other employment that is in conflict with your position at Sektor;
- r) not make any unauthorised statements to the media about Sektor's business (requests for media statements should be referred to Sektor's Directors);
- s) not fight in the workplace;
- t) not use inappropriate language in the workplace;
- u) never report for work in circumstances where there is a risk that you could be affected by or "under the influence" of illicit drugs or alcohol (eg if you have ingested or otherwise taken drugs or alcohol the night before or in the period leading up to your next work period). If a workplace participant is taking prescription medication, they must inform their manager at the commencement of their working day. Workplace participants may be required to produce medical evidence to prove their medication does not affect their capacity to perform their duties in a safe manner without harm to themselves or others; and

v) not smoke during working hours unless it is during prescribed breaks and within designated areas.

## **6. Issues for Managers and Supervisors**

6.1 Managers and supervisors are expected to:

- a) promote a team spirit;
- b) maintain confidentiality so far as is reasonably practicable when conducting investigations into grievances and disputes;
- c) avoid bias in decision making;
- d) ensure compliance with Sektor's procedures when carrying out counselling and discipline;
- e) exercise objectivity when administering rewards or discipline; and
- f) not condone, permit, or fail to report any breaches of the Code as outlined above by workplace participants under their supervision.

## **7. Breaches of this code**

7.1 A breach of this Code may lead to disciplinary action including, but not limited to, termination of employment or services.
